Sir,

As per the instructions from Govt. of India, Ministry of Home Affairs, New Delhi, the "**Fire Service Week**" is observed from 14<sup>th</sup> to 20<sup>th</sup> April every year to pay homage to the Gallant Fire Service Personnel who laid down their lives while performing their duties. This year also this Week will be observed from 14<sup>th</sup> to 20<sup>th</sup> April, 2014. Various programme will be arranged to create the awareness about Fire Preventions & Fire Precautions among the people.

02. On the first day of the Week generally inauguration of Fire Service Week is done at the Hands of His Excellency, the Governor of Maharashtra State at Raj Bhavan by presenting a Fire Service Day Pin Flag. Hon'ble Governor of Maharashtra appeals to the public to donate generously to the benevolent fund for the welfare of Fire Services Personnel and their families. During the Week various programme like Lectures and Demonstrations on Fire, Essay and Drawing Competitions for schools students, Radio & Doordarshan programme, Tactical Medley Fire Drill Competitions for regular Fire Services Personnel and Industrial & Public Fire Drill Competitions for Industrial Fire Services Personnel are arranged. 03. In view of above, the active participation of your Fire Service Personnel in various kinds of activities such as Industrial & Public Buildings Fire Drill Competitions, etc. is expected. The Industrial & Public Buildings Fire Drill Competitions on the following events have been arranged on **Tuesday , the 15<sup>th</sup> April, 2014 from 0800 hrs. onwards** at the Directorate of Maharashtra Fire Service, Maharashtra Fire Service Academy, Vidyanagari, Hans Bhugra Marg, Santacruz (East), Mumbai-400 098.

1. One man Fire Extinguisher Drill for male & Security Staff.  
[ Only one participant of each Team should take part in this event ]
2. One man Fire Extinguisher Drill for Officers.
3. One man Fire Extinguisher Drill for Female-worker & staff.
4. Kitchen Fire Drill for female.
5. One man Hose Reel Drill for male worker & staff.
6. Two men Hydrant Drill for Officers.

04. Instead of four participants of each team, only one participant should take part in the Event No.1. Accordingly, the rules of Event No.1 should be treated as amended. **There is a Entry fee of Rs.5,000/- (Rupees Five Thousand Only) per team.** All participants only will be provided tea, breakfast and lunch at the time of Competitions. Winners of 1<sup>st</sup> 2<sup>nd</sup> and 3<sup>rd</sup> of each event will be awarded Mementos and Certificates. However, the entry fee Rs.5,000/- for all Teams for this year on the condition that all the Industries should collect the Donation Boxes from this office and submit the donation received by them to this office by 30.04.2014.
