## INSTRUCTIONS:-

1. Application form filled by the applicant should be checked thoroughly, and particularly column No.11 by the Sponsoring Authority, wherein details of the service are to be incorporated. Designation/Rank should be written in full form and not in abbreviations. For example if the employee is holding the post of Station Officer, it should be mentioned as Station Officer and not as SO or ASO, etc. In case of Driver-cum-Operator, it should not be written as DCO.
2. Undertakings from the Sponsoring Authority regarding Medical Fitness in the prescribed format provided in the application form at Page No.3 duly signed by the Sponsoring Authority only will be accepted. Some of the Deptt. are forwarding the Medical Fitness duly signed by the Medical Officer/Board which is not acceptable. The Sponsoring Authority shall not send any Medical papers from Medical Officer/Medical Board to this College, except the Medical Undertaking.
3. Undertaking regarding Seniority is mandatory and it should be furnished in the order of seniority of the nominees. If more than one candidates are nominated from the same department, (for example, if the Deptt. nominates 6 candidates) common seniority of all nominees shall be given in the prescribed format for 6 candidates and shall be given in the individual application form.
4. Admission shall not be considered on the basis of old application forms and any incomplete information.
5. No documents in support of education qualification, technical qualification, experience and medical fitness shall be enclosed with application form, but details mentioned in the application form at Column No.9, 10 and 11 at Page No.2 of the application form require to be checked by the Sponsoring Authority.
6. Separate forwarding/covering letter for each course is essential and Phone No./Fax/Mobile No./Email/Website of the officer signing on the letter to be incorporated for contact if required.
7. The State where the Fire Service is controlled by the Local Bodies, the seniority list of the nominees of each Local Body viz. Municipality/Municipal Council/Corporation, should be furnished duly certified by the Commissioner/designated authority along-with the application of nominees of concerned Municipality/Municipal Council/Corporation.
