## OFFICE ORDER

Sub : Grant of Fire Approvals for the Buildings coming up in 10 Kms. perimeter area around Pimpri-Chichwad Municipal Corporation.

Ref : 1. Govt. Notification issued by Urban Development Deptt. Vide No.FFS-1410/25/CR-55/UD-20, dated 07.05.2010,  
2. Urban Development Deptt. G.R. No.TPS-1089/650/CR-1654/09/UD-13, dated 28.08.2009.

The Govt. of Maharashtra has appointed the Maharashtra Fire Prevention and Life Safety Measures Act, 2006 (hereinafter called as 'the said Act') in the 10 Kms. perimeter areas around Pimpri-Chinchwad Municipal Corporation, vide Notification under reference number 1 above.

02. In exercise of the powers conferred under section 2(9) of the Maharashtra Fire Prevention and Life Safety Measures Act, 2006 and Rule 3 of Maharashtra Fire Prevention and Life Safety Measures Rules, 2009 to the undersigned and as per the directives of State Government vide Govt. letter under reference 2 above, the following authorities are appointed to discharge the duties of the Nominated Officers for effective enforcement of the Law.

Sr. No.	Type of occupancies	Nominated Officers
1 (a)	All Townships notified as per the Township Notification of Urban Development Department No.TPS/1804/Pune-RDPCR/UD/13, dated 16/11/2005.	The cases will be dealt with by Directorate Maharashtra Fire Services and the Officers in the Directorate of Maharashtra Fire Services or Officers of other authorities will be nominated from time to time to assist the Directorate Maharashtra Fire Services. Explanation: 'Authorities' means authorities as defined vide section 2(7) and 2(12) of the said Act.
(b)	All classes of development on planning of more than 30 acres of land.	
(c)	Logistic hub, Warehousing on land pocket of 30 acres and above.	
(d)	Special Building such as Stadiums, public assembly places, etc.	

2	All other Building developments. Such as Residential, Commercial, Business buildings, Petrol Pumps, Solvent Storages, Gas Cylinder Storage sheds.	Pimpri-Chinchwad Municipal Corporation's Chief Fire Officer and he may nominate the Officers of Fire Department of Pimpri-Chinchwad Municipal Corporation who fulfilled the qualification prescribed under rule 3 of Maharashtra Fire Prevention and Life Safety Measures Rules, 2009, from time to time.

03. While granting permission to all other buildings in particular high-rise Buildings of more than 36 meters height the Chief Fire Officer of Pimpri-Chinchwad Municipal Corporation shall assess the Fire Service Infrastructure, Response Time from Pimpri-Chinchwad City and dispose off the cases at his level. If necessary, he may take advice of this Directorate from time to time

The above orders shall come in force with immediate effect.
