The 14th General Body Meeting of the Maharashtra Fire Services Personnel Welfare Association, Mumbai was held on **Saturday 20th July, 2013** at 11.00 hrs. at the Conference Room, Directorate of Maharashtra Fire Services, Santacruz (East), Mumbai 400098. The Officers/Members as per list enclosed were present for the meeting. At the outset, the President welcomed the members present for the Meeting. The proceedings of the meeting are as under:

Item No. 01 : To read and confirm the Minutes of the 13th General Body Meeting held on 28th March, 2012

The Minutes of the 13th General Body Meeting held on 28th March, 2012 were circulated to all Fire Services vide Endorsement WA/71-H/2012/35-A dated 27th April, 2012 and comments were called by 31st May, 2012. However, no comments have been received. The President requested the members to offer their views if any. However, there were no suggestions / comments from any members. Hence the minutes were confirmed.

The actions on pending issues of the earlier meeting are as under:

(a) Organization of Cultural Event.

In the last meeting held on 28.03.2012, it was suggested that the Cultural Events may be arranged by the Fire Services of Municipal Corporations preferably in November/December. The President therefore directed to issue circular in this respect to Fire Services of Municipal Corporations to hold Cultural Events preferably in November / Decembers, 2013.

Items of the Current Meeting

Item No. 02 Accord sanction to the expenditure up to 31st March, 2013.

The President informed that the Accounts of the Association for the period ending 31.03.2012 are complete in all respect. The accounts for the period ending 31.03.2013 have been prepared & submitted to the Auditor of the Association to examine and finalize the Accounts and thereafter submitting its Income Tax Returns as early as possible. Any member of the Association desiring to see the Accounts of the Association may see it. The information of expenditure incurred by the Welfare Association during the Financial 2012-13 was informed to the members including the Fire Service Week Scholarship and Medical/ Financial Aid etc. There were no comments/suggestions from the members. Hence, the expenditure incurred by the end of 31.03.2013 was unanimously approved by the General Body. The President again appeal the Fire Officers to collect maximum Donation to the Welfare Association.

Item No. 03 : Obtain the Consent of General Body for the revised norms in respect of Scholarship /Medical Aid etc.

The Revised Norms of the Welfare Association finalized in the 44th Meeting of the Managing Committee of the Association held on 15.10.2011 in respect of Scholarship/Financial/Mutual Aid were approved in the last General Body Meeting of the Welfare Association held on 28.03.2012. Hence, no action is necessary on this item.

Item No.04 : Subjects related to Maharashtra Fire Service.

The President of the Association informed that this point is not related to Welfare Association. Hence, no discussion on this issue was held.

Item No.05 : Any other item will be discussed with the permission of the Chair.

The President informed that the new staff is recruited by the local Fire Services. The new staff is not aware of the Schemes implemented by the Welfare Association. Hence, he requested the Fire Officers to acquaint the new staff about the Membership of the Welfare Association.

The President further informed that the Maharashtra Fire Services Welfare Association will carry out the Survey of Fire Services all Municipal Corporations / Councils/Nagar-Pachyants through The Tata Consultancy Services. The survey will include all information of Fire Service including information of all staff with their education, blood group ect. The tentative expenditure of it will be Rs. 15.00Lakhs.
