**OFFICE ORDER**

**Implementation of Maharashtra Fire Prevention and**  
**Life Safety Measures Act, 2006.....**  
**Ref: 1. Notification No. TPS-1818/CR-236/18/DP&RP/Sec.20(3)/UD-**  
**13, Dated 02.12.2020**  
**2. Staffing Pattern Approved by Urban Development**  
**Department vide Order No. MCO-2020/Pra. Kr. 140/UD- 14,**  
**dated 26.03.2021**

Urban Development has implemented "Unified Development Control & Promotion Regulation, 2020 "(UDCPR 2020) into the areas of Municipal Corporation, Councils and Regional Plans across Maharashtra in reference to Sr. No. 01 above. As per Clause 2.2.11 & 2.6.1 ii), the buildings identified in regulation 1.3 (93) (xiv) are supposed to be scrutinized by Chief Fire Officer of the Local Planning Authority or in absence of such officer, by Director of Maharashtra Fire Service or an officer authorized by him.

2. In reference to Sr. No. 02 above, Urban Development-2 has approved 36 Nos. of Asst. Director and equal No. of Fire Officer for each District in Maharashtra. The appointment of these officers are in process and may take some time, thus this office hereby issue order as an stop-gap arrangement to ease out the hardship faced by Developers / Promoters for sanctioning of building plans approval with respect to Fire and Life Safety Measures.

3. In exercise of the powers conferred under section 47(2) of the Fire Act, the undersign hereby delegates the power of scrutinizing the building proposal in accordance to UDCPR 2020, to the Fire Officer / Fire Officer In-charge of the Fire Service as per the Annexure – I for the areas (district / talukas) mentioned against their names. The said approvals shall be issued by the concern officers for the areas not covered by Urban Local Bodies or Special Planning Authority or where there is no Fire Officer available for the implementation of the Fire Act.

4. The delegation of power for the various occupancies is given in Annexure –II. All the proposals shall be received online on [www.mahafireservice.gov.in](http://www.mahafireservice.gov.in) website. The user name and password for each user for the respective district is given in Annexure – III.

5. The buildings shall be scrutinized in accordance to Schedule-I of the Fire Act and Part 4 of the National Building Code of India. Similarly, the inspection of all such buildings shall also be carried out at the time of issuing Final Fire Safety Approvals (Final No-Objection Certificate) by the respective officers.

6. The concern officers shall ensure that “Fire Service Fees” levied as per section 11 and Schedule II of the Fire Act are deposited as per details given in Annexure – IV or where details are not available then in following accounts in online manner.

7. After all the proposal are cleared by the respective officers, the records and register shall be maintained properly by them in their respective fire station for all future correspondence.

8. This office is working with MahaIT to modify Building Plans Approval Management System (BPAMS) software wherein Provisional Fire Safety Approval will be issued along with Building Plan approval through online process. Once this is rolled out, the same shall be communicated to all ULB's and SPA's separately.

9. The said order shall come into force with immediate effect till any further directives is issued by this office in this regard. Previous Orders issued in regards to Delegation of Power now stands cancelled.
