- 5 . 90% attendance is compulsory. Any Trainee found on leave for more than 40 days (July-2025 to December-2025 20 days and Jan-26 to July- 26 days-20 days) will not be made to seat for the final examination.
- 6 . Eating in Mess is mandatory. No outside food allowed.
- 7. The student coming later than 10 minutes after commencement of the classes shall not be allowed to attend the particular session.
- 8. Remaining absent from the classes without prior information and notice will warrant strict action from the authorities.
- . 9 Any student Remaining absent from the class for more than six consecutive days will result in termination of his admission and registration fee will stand forfeited.

Uniform & Turn Out:-

- 1. This is purely Residential Course and trainees are expected to stay in the accommodation provided by the Academy. The activities are scheduled on 24 X 7 basis with strategic breaks for health, hygiene and physical rest etc.
- 2. Attendance and participation in all activities prescribed and notified from time to time is mandatory requirement to inculcate discipline and alertness among the trainee officers.
- 3. Everyday training duration is from 06.30 hrs to 17.30hrs daily from Monday to Friday for both theory as well as practical's. Saturday and Sunday will not be holiday and trainees are expected to stay in the campus only except for leaves / weekly off with prior permission from Course Co-ordinator.
- 4. Remaining absent from the classes without prior information and notice will be considered as Absent and will warrant strict action from the authorities. Remaining absent without permission from the class for more than six consecutive days will result in termination of his admission and registration fee will stand forfeited.
- 5. 90% attendance is compulsory. Any Trainee found on leave for more than 50 days (January to July 25 days and July to December- 25 days) will not be made to seat for the final examination. No notice for such will be given.
- 6. Accommodation & Mess facilities are provided by the Academy. It is compulsory for the trainees to reside and eat food provided in the Mess. No outside food is permitted. No Eatables are allowed inside the room.
- 7. Smoking / Consumption of Alcohol / Gambling in any form / Playing Cards / Ragging shall be treated as "Serious Offence" and strict action deemed fit will be taken.
- 8. Outpass after 10.00 PM is not permitted. All trainees should report before10.00 PM in the Academy.
- 9. Books issued by the Library are to be returned within 03 days prior to the closing of their Course.
- 10. No-Objection Certificate is to be obtained from the Librarian, Mess Manager, Store In-charge, Uniform Deptt in the prescribed format and shall be submitted one day prior to the closing of the Course to the Course Co-coordinator.
- 11. Any Breakage / Missing of the Furniture shall be reported immediately to the Course Co-coordinator. Failing to report shall be deemed as broken / misplaced by the trainee and shall be recovered from him.
- 12. Trainees are expected to keep their rooms clean. However, the common areas shall be cleaned by housekeeping staff. It is advised to the trainees that valuable materials any shall be kept in the safe provided. The Academy shall not be responsible for lost or misplaced items.
- 13. The Training Academy is within the premises of Directorate of Maharashtra Fire Services. The outmost discipline is expected from the trainees.
