The Sub Fire Officer and Nominated Fire Officer Course is designed to develop the versatile feeder cadre of officers with the intention to provide competent and efficient fire and rescue services, effective enforcement of Maharashtra Fire Prevention and Life Safety Measures Act 2006 and Rules 2009.

- For Open Candidates: - Between 18 to 23 years (As on 1st August 2011)
- For SC/ST/NT/VJNT/SBC/OBC candidates relaxable upper age limit 5 years i.e. 28 years (As on 1st August 2011)

Educational Qualification: -

10+2 i.e. HSC - Science from any recognized Board with minimum overall 50% mark for open candidates (Minimum aggregate 45% marks are required in Physics, Chemistry and Mathematics.) & Overall 45% marks for SC/ST/NT/VJNT/SBC/OBC candidates.

(Minimum aggregate 40% marks are required in Physics, Chemistry and Mathematics.)

Or

B.sc. with physics, chemistry, Mathematics, I.T. or Forensic Science as one of the major subjects with minimum 45% marks for open candidates & 40% for SC/ST/NT/VJNT /SBC/OBC candidate.

Physical Standards: -

Height – minimum 165 Cms,

Chest - Minimum 81 Cms without expansion and Minimum 86 with Expansion (minimum expansion must be 5 Cms).

Weight – Minimum 50kgs.

Medical Standard:-

1. Eye Sight- Distant Vision 6/6 without spectacles. The candidates must pass high grade colour vision test.
2. Your chest should be well developed. The minimum range of expansion after full inspiration should be 5 cm.
3. Your hearing should be normal without any evidence of present or past disease of the ear, nose and throat.

- f) varicose vein

- j) Any hearing loss deficiency and speech deficiency such as Stammering.

Selection Procedure:

- Selection procedure is completely on the basis of merit.
- The candidates whose applications are found in order will have to appear and pass written test and physical standard test. Thereafter only successful candidates will be allowed to undergo Physical Efficiency Test. The date and place of written test, physical standard test and Physical Efficiency test will be informed suitably and/or the list of which will be put-up on website.
- The question paper will be to assess the general awareness/general knowledge, knowledge of analytical aptitude and ability to observe and distinguish patterns and to test the basic knowledge of candidate.
- Written Test :- (One paper of Total 100 Marks duration 1 hour)
 - a) English & Marathi – 50 Marks
 - b) General Knowledge, Aptitude Test, Logical reasoning – 50Marks
- Any mistake pertaining to (a) in-correct roll number, (b) Overwriting will not be evaluated.
- Passing marks required to appear for Physical standard test - Minimum 50%.

Physical Standard Tests:

Height, Chest and Weight measurements: Those who do not meet the required physical measurements will be eliminated at this stage.

Physical Efficiency test:

The candidates who clear the physical standard tests will be required to undergo following tests:-

Qualifying tests -- Score Tests: - (Total Marks – 35)

- Jump on jumping sheet from 20-25 feet height.-
(Candidate who is not qualifying this test shall be eliminated from the selection procedure)
- 60 mtrs. running in square with 50 kg Dummy –(Total 10 marks)

- Rope climbing 20 -25 feet only with hands. –(Total 10 marks)

(Swimming test is an additional skill test; candidate not completing this test will be losing marks but will not be disqualified from selection process.)

- The additional marks will be given for possessing following skills and certificates.-
(Total 15marks)
 1. Driving License – LMV and or HMV – (Total 5marks)
 2. NCC - B / C– certificate- (Total 5marks)
 3. National / State Level Sports Certificate issued by Competent Government Authority.- (Total 5marks)

Verification of Certificates:

- Testimonials of the candidates will be checked at the time of physical test.
- Original documents will be returned on the spot after verification and attested photocopies of certificates will be retained with the application.

Merit List:-

- Merit list will be drawn on the basis of marks obtained by the candidates in the physical test and written test.
- On the basis of this merit the candidates shall be short listed for detailed medical examination.
- There shall not be any waiting list.

General :-

- Incomplete application (without photograph, signature of candidate and parents etc.) will be rejected.
- The candidates should make their own arrangement of staying when they are required to undergo written, physical and physical efficiency tests.
- Candidates have to undergo physical and ground tests in any weather condition, as and when arranged.
- Candidates will have to appear for selection tests at their own expenses and risk.

- Mobile phone, Calculator, cameras or any such electronic instrument or gadgets and books, note books etc are strictly prohibited inside the test centers / during selection procedure, and if found will render him disqualified from the selection procedure.
- Candidate should apply only if he fulfils all the physical standards and qualification mentioned in the advertisement to avoid any disappointment at later stage
- Candidate has to report within prescribed time & date to the academy.

Fees :-

- Fees details:- Total course fees for external candidate Rs. 72,800/- (Tuition and Library fees per week – Rs. 700/- and Accommodation, electricity and water charges per week – Rs. 700/-)
- Course fees shall be paid at the time of admission within stipulated period. Failing to pay in stipulated time will result in cancellation of admission.
- Fee once paid shall not be refunded under any circumstance.
- Those discontinuing the course at any stage shall stand to forfeit their registration, admission and fee already remitted.

Attendance

- This is a residential course activity & will be scheduled on 24 X 7 basis with strategic breaks for health, hygiene and physical rest etc.
- Attendance and participation in all activities prescribed and notified from time to time is mandatory requirement to inculcate discipline and alertness among the trainee officers.
- Students are expected to be present early for the classes.
- The course duration shall be from 06.30 hrs to 17.30hrs daily from Monday to Friday for both theory as well as practicals.
- 85% attendance is compulsory to qualify for appearing in the final examination.

- Remaining absent from the classes without prior information and notice will warrant strict action from the authorities.

Uniform & Turn Out :-

- During training officer must maintain clean shave, proper hair cut , up to date uniform with polished shoes & belt and other accessories and present himself in discipline, with smart turnout and must demonstrate exemplary behavior, failing which, the candidate will be liable for disciplinary action deemed fit.

Discipline :-

- Strict discipline should be observed by the trainee officer while in classrooms, at training grounds or while moving in the surrounding premises of the fire academy.
- The officers are expected to come properly dressed maintaining a neat personal hygiene.
- The campus strictly prohibits habits such as smoking, chewing gum or pan etc.
- Indiscipline by the students shall be noted and reviewed seriously by the authorities.
- Any complaints or suggestions that need attention can be communicated to the Director.

Certification :-

- State Fire Academy will issue certificates to the students who successfully pass the examinations conducted at the end of academic year.
- This certificate shall be issued after 45 days from the date of the examination results.
- Those seeking certificates by post shall remit the required postage in advance with a letter mentioning the mailing address to which the certificate is to be sent.
